INSTALMENT PLAN FOR MEMBERSHIP DUES

Under the Instalment Plan, Members will remit \$468.75 in three payments of \$156.25 each, due on January 1st, April 1st, and July 1st. The first payment of \$156.25, plus two post-dated cheques for \$156.25 each, must be remitted to the MALA Office on or before January 1st. Default on any instalment renders entire balance due and payable immediately.

The Instalment Plan is also available to Associates, who will remit \$255.00 in three payments of \$85.00 each, due on January 1st, April 1st, and July 1st. The first payment of \$85.00, plus two post-dated cheques for \$85.00 each, must be remitted to the MALA Office on or before January 1st. Default on any instalment renders entire balance due and payable immediately.

Amended April 10, 2017

Per receipt of letter dated April 10, 2017 from CSLA President Gordon Smith, confirming that there would be no increase in 2018 dues for CSLA Members, but announcing the establishment of two new categories effective January 1, 2018: CSLA Associate (Intern) category (\$20.00 plus applicable Provincial GST) and CSLA Student category (\$0).
