## INSTALMENT PLAN FOR MEMBERSHIP DUES

Under the Instalment Plan, Members will remit \$682.50 (includes GST) in three (3) payments of \$227.50 each, due on January 1<sup>st</sup>, April 1<sup>st</sup>, and July 1<sup>st</sup>. The first payment of \$227.50, plus two post-dated cheques for \$227.50 each, must be remitted to the MALA Office on or before January 1<sup>st</sup>. Default on any instalment renders entire balance due and payable immediately.

The Instalment Plan is also available to Interns, Pre-Interns and Affiliate Members. Default on any instalment renders entire balance due and payable immediately.

Interns and Pre-Interns will remit \$283.50 (includes GST) in three payments of \$94.50 each. Due on January 1<sup>st</sup>, April 1<sup>st</sup>, and July 1<sup>st</sup>. The first payment of \$94.50, plus two post-dated cheques for \$94.50 each, must be remitted to the MALA Office on or before January 1<sup>st</sup>.

Affiliates will remit \$390.75 (includes GST) in three payments of \$130.25 each. Due on January 1<sup>st</sup>, April 1<sup>st</sup>, and July 1<sup>st</sup>. The first payment of \$130.25, plus two post-dated cheques for \$130.25 each, must be remitted to the MALA Office on or before January 1<sup>st</sup>.
